



Report Summary Information

Subject : Civil Court Record

Displays the civil court records as a result of a court ordering a business to make payment on the debt or an outstanding account. A judgement remains on a business profile for 5 years.

Subject : Default Data

Displays default data as supplied to TransUnion by credit grantors and relates to late or non-payment of accounts. A default against a business remains on the profile for 2 years if it relates to Bad Debt Written Off, Accounts Handed Over, Repossession and Credit Cards Revoked. For all other status type, the default will display on the profile for a period of 1 year.

Subject : Notarial Bonds

Displays information on all the notarial bonds held against the business. A notarial bond is a bond of moveable assets as registered at the Registrar of Deeds. These bonds are used to secure debt and are not considered negative information - it means that should a business liquidate, the holder of the notarial bond will have a preferential claim to the funds that have arisen from the sale of the movable asset.

Subject : Deeds Summary

Displays a summary of the properties owned, on the TransUnion database, per each deeds office. This information is supplied by the deeds office of South Africa and is updated on a monthly basis. The bond information displayed shows active bonds linked to the property which may not be in the name of the owner searched on.

What is a Bank Code?

Bank Code - Normal (B) or Full and General (F)


A bank code is a code provided by the banks on the individual's account. This is an investigation report that takes 24 hours and will be delivered to your bank code folder on the main menu of the Datanamix website. The user is required to enter the tenant's / individual's bank details: bank name, branch, account number and the terms of the enquiry. For example, should a business have signed a credit agreement of R10,000 credit facility, the terms would be R10,000 30 Days. (minimum bank code to be accepted is "C").

The codes are:

A: Undoubted for the amount of your enquiry

B: Good for the amount of your enquiry

- C: Good for the amount quoted if strictly in the way of business
- D: Fair trade risk for the amount of your enquiry
- E: Figures considered too high
- F: Financial status unknown
- G: Paper occasionally dishonoured H: Paper frequently dishonoured


